## Chamber to Launch "Buy Here. Thrive Here."

A Chamber initiative rolled-out six years ago to encourage more local buying will be getting an infusion of support and momentum – and even a new name – as it aspires to help businesses weather the tough times created by Covid-19. Officially "Buy Here. Thrive Here." becomes an offshoot of the Chamber's "Buy Here. Live Here." program. "Like its predecessor, it will emphasize to businesses and consumers the importance of making purchasing decisions with local companies in mind," explained Chamber Board Chair Darin Tornatore. "The biggest difference between the two programs is the degree of urgency. Our local businesses right now need immediate help just to stay afloat. They need



our entire community to direct their purchasing decisions, when at all possible, to those businesses in our county." The Chamber is also discussing the possibility of aligning with an innovative concept called "The PA 30-Day Fund" which would allow struggling businesses to apply for small grants that would help them buy time until the business was back on solid footing.

## Chamber Endorses Lawsuit Legislation to Protect Businesses

The Blair County Chamber joined chambers from throughout the Commonwealth in signing-on to a letter to the Pennsylvania Congressional Delegation urging their support of temporary, targeted legal safe harbor from unwarranted lawsuits. The letter was drafted by the Pennsylvania Chamber of Business & Industry. Employers face the likelihood of lawsuits alleging exposure to the Coronavirus on a company's premises or through their activities or products. Such unwarranted lawsuits could be the death knell for many businesses already having a difficult time getting back on their feet.
