## Rails To Trails Request Gets Chamber Board Support

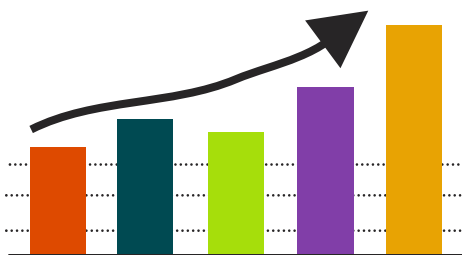

## Unemployment Compensation Increases Hurting Business Recovery

The harsh reality is that many businesses in our county can't find enough employees and some of those businesses are now faced with significant increases in their Unemployment Compensation cost. Although the state hasn't changed the rating formula, businesses with claims, including fraudulent claims, are seeing the impact of the pandemic in their unemployment comp payments because of their claims experience. To make matters worse, the state has had to borrow money to keep the Unemployment Compensation fund solvent and is expected to raise rates or add surcharges over the next several years.
