Chamber Encourages Reduction in CNI Tax Rate

The Blair County Chamber has signed on to a letter to the Pennsylvania General Assembly supporting a significant reduction in the Commonwealth's Corporate Net Income Tax Rate. At 9.99%, Pennsylvania has the second highest CNI in the country. That rate puts the state at a competitive disadvantage, acting as a roadblock to attracting new talent and new business opportunities while stifling investment and economic



growth. The letter to the General Assembly has been signed by chambers from throughout Pennsylvania.
