## Public Policy Committee to Host 80th District Q&A

The Public Policy Committee of the Blair County Chamber will spend its next regularly scheduled meeting on April 4th learning more about the business priorities of the two Republican candidates for State Representative in the 80th District. Incumbent Jim Gregory and challenger Scott Barger will answer questions from the committee. That Q&A will be videoed and then made available to the public on Altoona Public Access and at least two YouTube sites. “As the most high-profile race of this primary season, our committee felt that it was important to see how each of these candidates prioritize business issues,” explained Lisa Hann of Family Services, Inc., who chairs the committee. Initially, the committee discussed hosting a debate between the candidates but felt that a format which brought them in separately would provide flexibility and less possible conflict. “Both candidates will answer the same questions,” Hann pointed out. “We’ve allocated twenty minutes for each candidate and we’ll designate a timer to increase the chance that the full slate of questions will be answered.” Only members of the Public Policy Committee will be permitted to attend the meeting. Gregory’s time slot will be 8:10 to 8:30 a.m.; Barger’s 8:40 to 9:00. Times to view the video will appear on the Chamber’s social media platforms.
