The Blair County Chamber joined nearly 80 other chambers from across Pennsylvania in urging safe harbor protections for business. A letter was sent by the PA Chamber of Business & Industry to federal and state lawmakers emphasizing smart policies out of Harrisburg and Washington, D.C. to help remove obstacles to economic recovery. "The threat of unwarranted lawsuits related to Covid-19 have many businesses on edge," reported Blair County Chamber President Joe Hurd. "We signed a similar letter of support for our business community in June but



apparently the issue is bubbling-up again. Businesses have suffered enough, thanks to a variety of poor decisions and mandates. To put them further on the defensive is misguided and overtly unfair."
