Fiore helped keep Chamber on solid footing

As Richard Fiore, Jr. passed the ceremonial gavel to Clark Stapelfeld at the Blair County Chamber's Annual Meeting, you could sense a mix of satisfaction and relief. For the past two years, Fiore has chaired the Board of Directors at perhaps the most challenging time that the organization has ever experienced.

"At a time of great uncertainty, Richard – and Darin Tornatore before him – grabbed hold of the situation and kept us moving forward," acknowledged Chamber President Joe Hurd. "A lot of organizations like ours struggled to regain their footing. Some are still trying."

Without question, Covid-19 set the Blair County business community into a tailspin. Many businesses were not permitted to remain open. Those that were had a host of restrictions that threatened to set them back for long periods of time. The Chamber actually called its entire membership – more than 1,000 busi-

nesses – to determine where it could help. Fiore helped spearhead that effort.

"We needed people to know we were behind them and willing to do whatever we could to get them through an unbelievably rough time," he pointed out. "We also helped a lot of non-members. As a business community, under circumstances like these, it makes no sense to pick and choose."

The pandemic created significant financial difficulties for Chamber members when it came time to renew their memberships. Fiore worked with the Chamber staff to create a Unity Fund in which businesses that could contribute money to help those that had run short were encouraged to do so.

"We said from the beginning of Covid that we wanted to guarantee that no one would lose their membership in the Chamber due to an inability to pay," Fiore explained. "We were so impressed with the businesses that stepped-up. It said a lot about our community."

While many of the busi-

nesses were trying to stay afloat, the Chamber itself had a difficult time as well. Program and event income ground to a halt. For more than a year, the primary source of funding were some dues revenue and some rainy day resources that had accumulated over the years. It became necessary to furlough a few staff while new strategies were set in place.

"I was disappointed about the cancelled events, programs and committee meetings during Covid," Fiore admitted. "But I believe the organization is stronger today having been through the many challenges thrown our way. I believe it refocused us and showed us the importance in coming together as a community to honor, learn, teach and network together."

He's confident that he leaves the Board Chair role in good hands.

"Clark is a dynamic leader who always has thoughtful opinions that get directly to the point," Fiore disclosed. "He brings his experience at New Pig as a multinational

corporation CEO to our board, broadening our view and helping us to think big beyond our region."

As far as Fiore's future involvement with the Chamber is concerned, he must first serve as Immediate

Past Chair until the end of 2023, a role that will keep him engaged with a number of initiatives that were introduced during his tenure. After that?

"I plan to become involved in some of the com-

mittees where I started my Chamber involvement," he noted. "I've lost touch with a lot of those during the time that I've needed to focus on my board leadership duties. It will be good to help wherever I can."

Committee leadership rates high marks

Few associated with the Blair County Chamber would question the value of Chamber committees to the overall value of the organization. Fewer yet would question the quality of those who lead those committees.

"It would be a great misconception for anyone to assume that the leadership of the Chamber was solely the responsibility of the board of directors," acknowledged Board Chair Clark Stapelfeld. "Our committee chairs, vice-chairs and co-chairs provide the direction at the grassroots level that makes the whole process run smoothly. They run interference for the board."

The connection between board members and committee chairs is practically seamless. A high percentage of board members chaired committees prior to being elected to the board. In fact, four current board members – Superman

Berrow, Joe Diamond, Alex Seltzer and Matt Muccitelli – are still chairing committees.

"When our Nominating Committee looks at potential board members, committee service is one of the factors they consider," Stapelfeld, a former chair

of the Public Policy Committee, explained. "When a board can reduce the learning curve for new members, it has the ability to gain momentum a lot earlier."

So how does someone become a committee chair? "The standard joke is that they are usually nominated

when they miss a meeting," Stapelfeld kidded. "In reality, it's someone with a passion for what a committee is hoping to accomplish. They mostly self-identify. It seldom happens that a person who has great enthusiasm turns-down a chance to chair."
