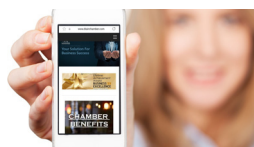

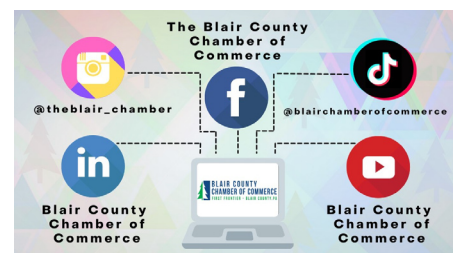
New Technology Committee Seeking Members
